Next, the agenda items were taken up and the following resolutions were taken:

Item No. 1: Confirmation of minutes of the 5th Senate Meeting held on January 20, 2022.

Item No. 2: Action taken report on the resolutions of 5th Senate Meeting.

The Senate was informed that the PhD enrolment of Fakruddin Ali Ahmed and Anindita Sarkar have been cancelled.

Item No. 3: Academic calendar for Autumn 2022-23.

The Senate approved the academic calendar noted in Annexure-1.

Item No. 4: Achievements of faculty members and Students of IIIT Kalyani.

Item No. 5: Cancellation of PhD enrolment.

The Senate approved the cancellation of enrolment of Sunil Gupta and Prasanta Mandal. For Ipsita Ghosh, a letter be sent from the Institute asking her views about continuation of PhD. In the event of not receiving satisfactory reply, the enrolment be cancelled.

Item No. 6: To allow existing PhD scholars of different categories to be converted into regular scholar with Institute Teaching Assistantship.

The Senate agreed to extend the facility to the existing scholars of other categories, however, it should be advertised among all such scholars and proper test and/or interview be held to select the candidates to be offered the Teaching Assistantship.

Item No. 7: Request received from Dr. SK Hafizul Islam to continue PhD co-supervision of a PhD student Ms. Preeti Soni at IIT (ISM) Dhanbad, Jkharkhand.

The Senate approved the request.

Item No. 8: Request received from Dr. Sanjoy Pratihar to continue PhD supervision of a PhD student Md. Ajij at NIT Meghalaya.

The Senate approved the request.

Item No. 9: Ratification of the decision to allow Ms Srutiparna Neogi to continue her PhD on medical ground, accommodating the break.

The Senate allowed the student to continue her PhD work.
